An External Pin Pad must Be Used to Process Debit Pin Based Transactions for all New Merchant Accounts on the Above listed Terminals, as **"These Internal Pin Pads are Not PCI Compliant Pin Pads."**

## **" OBSOLETE - USED -- ILLEGAL PIN PADS "**

Talento Pin Pad, VERIFONE 101\*,201\*,1000\*,1000SE\*, HYPERCOM S7,S8,S9, P1300, P1310, NURIT 202, 222, 252, 292 Pin Pads Are All Obsolete & Illegal.

\*(The VERIFONE 1000SE/180 is PCI COMPLIANT, & REPLACES THIS PIN PAD.)

+All PIN PADS with DUKPT Encryption Stickers on bottom of Pin Pad.

The Pin Pads shown above **"CAN NOT"** be **"RE-ENCRYPTED"** & Re-used for Debit Card Sales. The Pin Pads shown above will become Obsolete as of JULY 1, 2010, for any Merchant currently processing and using one of these Pin Pads. New Pin Pads Will be Required by the Debit Networks for Increased Encryption Security. Do NOT Allow a Sales Rep. to Sell you one of the Pin Pads listed above, as they are NOT PCI Debit Certified by the Debit Networks and will become Obsolete at the End of 2009. If the Pin Pad No Longer Works, It must be Replaced with a New PCI Compliant Pin Pad.

**+ALL PIN PADS WITH DUKPT ENCRYPTION STICKERS ON THE BOTTOM OF THE PAD.**

States can Impose large Fines for merchants using terminals that do Not Print the Last 4 Card Numbers Only on Customers & Merchants Receipt.

**ALL MERCHANTS MUST BE PCI & EMV CARD COMPLIANT & CERTIFIED WITH VISA/MASTERCARD EACH YEAR or be FINED MONTHLY. THIS IS NOT AN OPTION!**
